2021 HIGHLIGHTS AND INITIATIVES

NFCRV DONORS

The NFCRV is grateful to the Helen Brach Foundation and the National Council of Catholic Women for their continued support of our mission as well as the Conrad N. Hilton Foundation and GHR Foundation that helped us establish the fund for the benefit of NRVC member institutes. Since

its inception, the NFCRV has granted \$980,317 toward the educational debt of approximately 49 candidates to religious life. All of this is done through the generosity of our supporters and benefactors. NRVC continues to seek new sources of funding to maintain a sustainable financial model.

NFCRV ESTABLISHES THE DECADE OF PROMISE CLUB

In planning for the next generation of Catholic sisters, brothers, and priests, the Vocation Fund welcomed charter members to its newly established Decade of Promise Club. By year's end we had raised \$10,660 in collected funds and \$7,650 in pledged funds for a total of

\$18,310. Our hope is to raise more than \$100,000 over the next 10 years to assist candidates to religious life with educational debt.
