

EXECUTIVE DIRECTOR OVERVIEW

It is wonderful to be in the midst of Catholic Theological Union here in Chicago, a key place of educating Catholic pastoral leaders. One of the many benefits is that we are able to give witness to diverse Catholic traditions and participate in many of the liturgies conducted on campus.

I've personally participated in Catholic Sisters Week events, Brothers Day gatherings, and recently attended an Ordination Mass.

At Mass, Bishop Mark Bartosic spoke about a religious who was being touted as a founder but this priest goes on to rebuke the attribute saying I'm no founder, I was just the first one here to address the need.

At NFCRV we are just shy of five years young and are so thankful to be able to have helped dozens of religious sisters, brothers, and priests with their educational debt. The reason we are able to do this is because many people have been the first ones here to address the need. We are so thankful to the

Conrad N. Hilton Foundation, GHR Foundation, Helen Brach Foundation, and the National Council of Catholic Women for their continued support of our mission, and to our charter individual donors who have answered our appeal to address the obstacle of educational debt to religious life.

Graduations are a time of new beginnings and we recently heard how Robert F. Smith, the philanthropic billionaire, made a remarkable decision to assist over 400 young men at Morehouse College by paying off all of their educational debt.

We haven't achieved that as of yet but we have committed close to \$400,000 towards the educational debt of 40 young women and men who will change the world.

All of this done as a benefit of Religious Institutes who are members of the National Religious Vocation Conference and because of the generosity of supporters and donors like you. On behalf of our NFCRV Board and all of our grantees I thank you.

Open our eyes Lord and let us respond generously. With you in hope and forever grateful.



DONOR OUTREACH

The NFCRV is grateful to the Helen Brach Foundation and the National Council of Catholic Women for their continued support of our mission as well as the Conrad N. Hilton Foundation and GHR Foundation that helped us establish the fund for the benefit of NRVC member institutes. Since its inception, the NFCRV has granted \$864,363 toward the educational debt of approximately 40 candidates to religious life. All of this is done through the generosity of our supporters and benefactors. NRVC continues to seek new sources of funding to maintain a sustainable financial model.

OUR MISSION

The National Fund for Catholic Religious Vocations (NFCRV) serves as a sign of hope in the future of consecrated life and is dedicated to increasing the number of women and men entering religious communities.

The Fund hopes to accomplish this goal by:

Offering financial assistance to religious institutes so that they may accept candidates who have student loan obligations.

Assisting congregations in developing policies and resources so that they may work effectively with those who have educational debt.

Inviting contributors to invest so that the vital legacy of religious life continues for the Church and the world.

The Fund awards grants based on need. Any canonically recognized religious institute with membership in the National Religious Vocation Conference may apply for a grant to service a candidate's educational debt during formation.
