# LETTER FROM OUR BOARD CHAIR

## RETURN TO CLOSE ENCOUNTERS

IN A HOMILY LAST YEAR, Pope Francis defined what we faithful mean by encounter: Gospel. Crucifix. Witness. Specifically, the Gospel, where we encounter and come to know Jesus by listening to Him; the Crucifix, where we encounter the love of Jesus, who gave Himself for us; and Witness, where we encounter Christ through the charity of others. These three things, Pope Francis says, “bring coherence between our faith and our life, between our words and our actions.”

As the pandemic eased in 2022, we were finally able to return to face-to-face or physical encounters with each other, and in so doing, encounter Christ Himself. We could again get our hands dirty and be among the sheep, as Pope Francis would say. Indeed, in January I led a group of seminarians to do just that—get dirty chopping wood for members of the Louisville, KY, community. Such generous service is what our NFCRV grantees are dedicating their lives to. They are out among the Good Shepherd’s sheep, bringing them the Gospel and the Crucifix. They are living the life of a Christian Witness. In short, they are facilitating close encounters with Christ for all those they serve.

Our goal is to ensure that educational debt does not create an obstacle for these sacred encounters. For those of us at NFCRV—our board, staff, grantees, and generous supporters—we are committed to building what Pope Francis calls a “culture of encounter.” We stop, look, listen, and act, never being indifferent to the struggles of others.

As you review the 2022 Annual Report, you will see we continue to make inroads in terms of our financial strength, mission support, and expansion.

With the support of our founding sponsors and benefactors, including the Helen Brach Foundation, the National Council of Catholic Women, and the members of the Decade of Promise Club—we have developed a healthy portfolio and act as good stewards of the financial resources entrusted to us, including charitable bequests and annuities, stock, IRAs and trusts. # VOCATION FUND IN THE NEWS

## SPOTLIGHT ON THE “BEAUTIFUL” WORK OF THE VOCATION FUND

Vocation Fund grantee Salesian Sister Pamela Rose F.M.A. was featured in a *National Catholic Register* story by Kimberly Jansen on “Eliminating Debt, Fostering Vocations.”

Sister Rose recalled, “feeling ‘awestruck’ the first time she met her aunt, a cloistered sister in the Philippines. However, when she wrote “nun’ on a career inventory at her public school, the teacher sent her to the principal’s office for not taking the assessment seriously.”

Rose says people thought she was joking, but eventually after suppressing her call for time, the desire was reignited after a mission trip in college. Only now she faced a new obstacle to her vocation: educational debt.

Enter the National Fund for Catholic Religious Vocations.

Salesian Sister Margaret Wilhelm, treasurer of the Salesian Sisters in Haledon, called the National Fund for Catholic Religious Vocations “a beautiful arrangement.”

“To absorb the level of debt many young women have accrued is staggering. [The NFCRV] helps us say ‘Yes’ to someone discerning in a timely manner.”

## STUDENT DEBT’S IMPACT ON VOCATIONS CAPTURES THE EYE OF WALL STREET

Vocation Fund Executive Director Phil Loftus was featured in a *Wall Street Journal* article by Francis X. Rocca on the obstacle educational debt poses to Catholic religious vocations. In addition to providing background information for the story, Loftus outlined the commitment the National Fund for Catholic Religious Vocations has made toward addressing the

problem: “The NFCRV has awarded nearly \$1 million to assist 49 people since its founding in 2014.”

Sister Colleen Mattingly A.S.C.J., vocation director for the Apostles of the Sacred Heart, a former NFCRV grantee community, captured the challenge well when she described turning away “two aspirants whose educational debt was too large to pay off before they reached 35, the maximum age allowed for new members.”
